F.1 Bill 98: Better Schools and Student Outcomes Act – Director's Performance Appraisal; Chair Wilson

G. INFORMATION ITEMS

G.1 Interim Financial Report; Superintendent Hutchinson

Superintendent Hutchinson introduced Traci Bloomfield, Manager of Finance, who provided the interim financial report, showing a compliant budget, according to financial indicators. Total revenue is consistent with prior year. The summary of enrolment estimates an increase of 0.3%. The next report will be presented to the Board of Trustees in June.

G.2 Enrolment & GSN Summary; Superintendent Hutchinson

Superintendent Hutchinson presented the first of the 2024-2025 Enrolment and Core Education Funding (formerly Grants for Students Needs) presentations to the Board of Trustees. The current forecasted enrolment is showing an overall decrease of 1%, although historically this could change, closer to the new school year.

Core Education Funding is the restructured version of the former Grants for Student Needs (GSN), supporting a "back to basics" focus, school board accountability and transparency. There are 28 allocations within 6 funding pillars. Superintendent Hutchinson shared the census and data updates and the adjusted formula for Transportation. Further detail will be provided at a future presentation to the Board of Trustees in June.

G.3 Raisin River Heritage Centre; Superintendent Hutchinson

Superintendent Hutchinson provided an update on the destruction of the Raisin River Centre, which is scheduled to be completed by September 2024. The Township has had many conversations with the school administrator and Superintendents to ensure the school community is not affected by the demolition.
