# G. <u>INFORMATION ITEMS</u>

# **G.1** Enrolment Projections; Superintendent Hutchinson

Superintendent Hutchinson presented the 2024-2025 Enrolment Projections, from the end of September 2024. Enrolment has increased by 2%, mainly in the JK & SK grades. Primary Class Size Compliance was reported to the Ministry of Education and at least 90% of all primary classes have 20 or less students. The next enrolment reporting period will be presented to the Board of Trustees in December.

# G.2 Occupational Health & Safety; Superintendent Finnegan

Superintendent Finnegan presented an Occupational Health & Safety update; including Joint Health & Safety Committee objectives, accident and injury prevention training, MLITSD audits performed in the 2023-2024 school year, and a summary of updated Health & Safety administrative procedures. She concluded with a summary of the 2022-2023 SBCI Report, reporting numbers and causes of CDSBEO incidents compared to the province.
