Under the direction of the Superintendent of School Effectiveness and the Principal of Special Education, the Speech Language Pathologist is responsible for the overall implementation of speech and language services to those students experiencing speech-language difficulties for students to achieve success in an academic setting.

- Responsible for providing complete speech and language assessments; administer standardized tests to individual students in a one-to-one testing situation.
- Accurately score the tests and interpret the significance of these scores in order to determine the presence of a speech and/or language delay disorder/delay; write a written report describing the test results and interpreting the significance to learning and outline specific recommendations.
- Provide parents and teachers with verbal feedback concerning assessment results and recommendations for programming.
- Provide speech and language services to students; develop and monitor individualized programs based on a students' speech and language needs.
- Implement these programs through delivering speech and language therapy to individual and/or small groups of students, including the provision of written reports to explain assessment results.
- Provide parents/teachers with follow-up activities and resources for future successes.
- Write year-end summaries of students' progress.
- Develop individualized home programs for parents.
- Supervise Communication Disorder Assistants (C.D.A.); select students whose needs can be met with a Communication Disorder Assistant.
- Provide C.D.A.'s with goals for each student.
- Supervise the delivery of these programs through regular meetings and consultation.
- Participate as an active member of an interdisciplinary team; meet with the team members on a regular basis.
